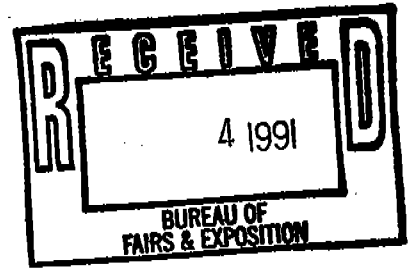

PREFACE

OPERATORS MANUAL

THIS OPERATORS' MANUAL IS NOT INTENDED TO TAKE THE PLACE OF SOUND JUDGMENT AND GOOD COMMON SENSE. PLEASE OBSERVE THE FOLLOWING CONDITIONS AND SUGGESTIONS:

1. OBSERVE GROUND CONDITIONS--MAKE CERTAIN THE RIDE IS ON FIRM FOOTING.
2. CHECK FOR OVERHEAD OBSTUCTIONS--ESPECIALLY POWER LINES AND TELEPHONE LINES.
3. BE AWARE OF WEATHER CONDITIONS WHICH MIGHT AFFECT THE SAFETY OF CREW AND CUSTOMERS.
4. ALWAYS BE AWARE OF LOCAL RULES, LAWS, AND CUSTOMS.
5. MAKE CERTAIN THAT ALL OPERATORS ARE FAMILIAR WITH OPERATING PROCEDURE AND SAFETY REGULATIONS.

## OPERATORS MANUAL

### DAILY INSPECTION PROCEDURE

1. CHECK ALL L-PINS AND R-KEYS IN ALL PANELS IN MAZES. MAKE SURE THEY ARE SECURE.
2. CHECK SUPPORT JACKS UNDERNEATH FUN HOUSE PLATFORMS. RETIGHTEN AND ADJUST AS NECESSARY.
3. CHECK ALL HANDRAILS FOR PROPER PINNING.
4. MAKE SURE THAT ALL R-KEYS AND BRACES HOLDING DISTORTION MIRRORS ARE IN PLACE AND SECURE.
5. CHECK ALL MOVING FLOORS FOR WATER OR DEBRIS, OR ANY OTHER OBSTRUCTIONS.
6. INSPECT ALL SAFETY GUARDS ON MOVING FLOORS.
7. INSPECT THE FUN HOUSE AND SURROUNDING AREA FOR ANY CONDITION THAT MIGHT CAUSE A PROBLEM OR SITUATION THAT COULD CREATE AN UNSAFE ENVIRONMENT FOR YOU OR THE PUBLIC. CORRECT IT BEFORE OPENING.
8. MAKE SURE ALL BRIDGES ARE SECURE.
9. CHECK THAT EMERGENCY EQUIPMENT IS FUNCTIONING PROPERLY.
10. MAKE SURE THAT ALL MANUAL SHUT-OFF SWITCHES ARE WORKING PROPERLY.

### END OF DAILY INSPECTION

AFTER COMPLETION OF THE DAILY INSPECTION YOU ARE NOW READY TO BEGIN OPENING PROCEDURES.

1. TURN ON ALL BREAKERS.
2. ALLOW ONE EMPLOYEE TO WALK THROUGH THE FUN HOUSE TO CHECK THAT EVERYTHING IS FUNCTIONING PROPERLY.

### OPERATIONS PROCEDURE

THIS OPERATIONS MANUAL WILL ASSUME THE FUN HOUSE HAS BEEN

PROPERLY ERECTED AND THE DAILY INSPECTION HAS BEEN PERFORMED AS CALLED FOR IN THE MANUAL PROVIDED.

- A. A NORMAL CREW WILL BE 3 RESPONSIBLE PEOPLE.
1. ONE PERSON AT THE ENTRANCE.
  2. TWO PEOPLE AT THE EXIT.
- 
1. THE PERSON AT THE ENTRANCE WILL COLLECT TICKETS AND ASSIST PEOPLE ACROSS THE MOVING FLOOR AT THE ENTRANCE TO THE FUN HOUSE. IF A PROBLEM ARISES THIS PERSON HAS A MANUAL SHUT-OFF SWITCH FOR THE MOVING FLOOR. THIS PERSON SHOULD ALSO WATCH FOR SIGNS OF UNUSUAL CIRCUMSTANCES. FOR EXAMPLE, DRUNKENNESS, CONFUSION DUE TO DRUG USE, OR OTHER SUCH CONDITIONS WOULD BE REASONS TO REFUSE ENTRY.
  2. THE SECOND AND THIRD EMPLOYEES ARE RESPONSIBLE FOR UNLOADING THE PUBLIC FROM THE CONVEYOR BELT. THEY DO THIS BY HOLDING THE LEGS OF THE PEOPLE UP AND LETTING THEM FALL GENTLY ONTO THE CUSHION AS THEY COME DOWN THE CONVEYOR BELT. THEY ARE ALSO RESPONSIBLE FOR KEEPING THE EXIT AREA CLEAR AT ALL TIMES. THEY SHOULD MAKE SURE THE PEOPLE COMING DOWN THE BELT ARE SPACED OUT PROPERLY. IF A PROBLEM ARISES THEY HAVE A MANUAL SHUT-OFF SWITCH TO STOP THE CONVEYOR BELT.

#### OPERATING CONDITIONS

##### STEADY OR HEAVY RAIN:

SLOW DOWN THE PUBLIC AS MUCH AS POSSIBLE. IF A MOVING FLOOR BECOMES TOO WET IT SHOULD BE SHUT OFF. CHECK CANVAS COVERINGS FOR WATER BUILDUP AND DRAIN IF NECESSARY. SWEEP HEAVY CONCENTRATIONS OF WATER OFF PLATFORMS.

##### THUNDERSTORMS:

IF A THUNDERSTORM CONTAINING LIGHTNING IS APPROACHING, CLEAR THE FUN HOUSE OF ALL PATRONS, THEN OPERATORS.

#### MAINTENANCE PROCEDURES

1. CHECK ALL DRIVE BELTS DAILY. TIGHTEN IF NECESSARY.
2. CHECK FOR UNUSUAL WEAR ON CONVEYOR BELTS, MOVING FLOORS DAILY.
3. CHECK ALL L-PINS AND R-KEYS ON MAZE WALLS DAILY.

4. OIL ALL BEARINGS ON MOVING FLOORS ONCE EVERY TWO DAYS.
5. CHECK AND TIGHTEN BOLTS OF BRIDGES AND MOVING MECHANISMS WEEKLY.

SAFETY AND EMERGENCY PROCEDURES

IN CASE OF LOSS OF POWER, EMERGENCY LIGHTS WILL COME ON. SHUT OFF MAIN DISCONNECT, SO THAT THE FUN HOUSE DOES NOT COME BACK ON UNEXPECTEDLY. OPERATORS SHOULD ENTER THE FUN HOUSE AND CALMLY REMOVE THE PUBLIC FROM IT SLOWLY.

BEFORE STARTING UP AGAIN, ONE OPERATOR SHALL GO THROUGH THE FUN HOUSE AND CHECK FOR PEOPLE AND OBSTRUCTIONS.
